Fair Care Learning and Training for Inclusion and Self-determination in Long Term Care (FairCare)</p> <p>Fair Care Learning and Training for Inclusion and Self-determination in Long Term Care (FairCare) is an Erasmus+ KA2 project that involves the cooperation between Germany, Hungary, Italy, Ireland and Spain.</p> <p>FairCare will develop a holistic and comprehensive training program implemented in local FairCare Training Centres to empower people with disabilities and/or in need of care to exercise self-determination in long term care. This will support them in effectively communicating their own needs and desires to their informal (e.g., relatives and partners) and formal carers (e.g., professional nurses) and, thereby, exercising greater self-determination in their daily lives. In close collaboration with</p>

the target groups, FairCare will develop, pilot, and implement in person and online learning and training supported by the FairCare collaboration tools in local FairCare Training Centres.

1. Promoting inclusion through Social Innovation Education (SIE4P.Inc)

Promoting inclusion through Social Innovation Education (SIE4P.Inc) was an Erasmus+ KA2 project that involved cooperation between France, Greece, Romania, Cyprus and Ireland.

The SIE4P.Inc project sought to address the problem of the lack of opportunities for empowering students with AEN (Additional Educational Needs) to become agents of change by creating the first-ever framework, resources, and training for inclusive Social Innovation Education (SIE). The project's target groups (young people with AEN, teachers, and youth volunteers) benefited from the inclusive framework, the training, and the resources that were developed during the life of the project. 2. Youth Empowerment for Social Inclusion (YES-SI)

Youth Empowerment for Social Inclusion (YES-SI) was an Erasmus+ KA2 project that involved cooperation between Germany, Greece, Italy, Spain and Ireland.

The YES-SI project aimed to empower young people, bringing them together, making them aware of their capacity to change their circumstances and those of their communities and realizing their own changemaker projects. YES-SI intended to raise awareness among young people of their powers and potentialities in order to prompt them to act both for their personal and collective development through social and civic innovation directly supporting their community needs. The project targeted young people (age 18-25), especially NEET / disengaged youth, youth workers, and youth work organisations. Our vision spreads across a network of 20 countries and a 35 year track record of pioneering social enterprise and social awareness at the heart of economic development. The Tuatha team has worked with communities and young people in Ireland, other European countries as well as in Asia and Africa. The team is based in Ireland but has active 10 team members based in the UK , Nigeria, Indonesia and Panama. As well as rooted in the Irish experience the company brings a wide experience from other European countries, Asia and Central America. The core work of SEi Tuatha is around education, social enterprise and especially using social enterprise to help communities develop their own economies and become sustainable. Within the team there is an enterprise education team that is working on a number of projects in Europe developing Social Innovation Education in schools and learning institutions, helping young people and adults become leaders in their communities. In terms of social enterprise SEi Tuatha is championing and pioneering Shared Wealth Social Enterprises, a new model of social enterprise that focuses on the fair distribution of wealth, Social Auditing as a way of creating an accountable statement of purpose for enterprises and Social Licencing as a way for enterprises to collaborate based on common values and social objectives.
